- Event:** Climbing Merit Badge available to ALL Scouts, Required for Joshua Tree Trek
- Date:** February 18th
- Description:** - Required instruction for Scouts planning to go on the Joshua Tree Climbing trek, a day trek to the Solid Rock Gym in San Marcos. Trained Climbing instructors will demonstrate equipment, techniques for Top Rope climbing, and Safety on the climb. If you already have earned the badge, you are eligible for Joshua Tree. An additional session with the Merit Badge Counselors will be required to complete the Merit Badge. Joshua Tree Trek is not required to earn the climbing badge.
- Open climb for scouts that have previously taken the Merit Badge course, and want to gain further experience and practice.
- Prerequisite:** None, however, this is a required Merit Badge training for those going to Joshua Tree in March if you haven't completed the badge already.
- Meet at:** Sports Authority Saturday 18th February @ 8:30 am (Rock Gym 9:00 am to 2:00 pm)
- Return:** 18th February Trek returns by 2:30 pm
- Cost:** \$30/Scout for Merit Badge Instruction, \$14/Scout for open climb
